
WHEREAS, GHQ AFP SOP Nr 9,s-2017 (Guidelines Statement of Assets, Liabilities and Net Worth), s-2017 in conjunction with CSC Memorandum Circular 15, s-2015 prescribes suspension of one month & 1day to 6 months for the 1st Offense, and dismissal from the service for the 2nd Offense on non-filing of SALN;

WHEREAS, Section 8, RA 6713 (Code of Ethical and Standards and Conduct for Public Officials and Employees) prescribes imprisonment not exceeding five (5) years, or a fine not exceeding FIVE THOUSAND PESOS (PhP 5, 000.00), or both, at the discretion of court for unlawfully taking/use of any Statement filed for purposes contrary to morals or public policy or any commercial purpose other than by news and communications media for dissemination to the general public;


WHEREAS, the aforementioned laws also provides that non-filers of SALN are not entitled to the Performance Based Bonus;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that no investigation whatsoever will be conducted by the Committee against any Military Personnel under Program –IV considering that they substantially filled out and filed before 30 April 2023 their respective SALN pursuant to the provision of RA 7613 and GHQ AFP SOP Nr 09 dated 28 June 2017 (Guidelines Statement of Assets, Liabilities and Net Worth).
