SWORN STATEMENT OF ASSETS, LIABILITIES
AND NET WORTH (SALN) FOR CALENDAR YEAR (CY)
2023 OF THE MILITARY AND CIVILIAN PERSONNEL UNDER
PROGRAM IV OF THE ARMED FORCES OF THE PHILIPPINES

WHEREAS, the General Headquarters (GHQ) Statement of Assets, Liabilities and Net Worth (SALN) Review and Compliance Committee of this Office (Committee) is mandated to review the submitted SALN for CY 2023 of all Military and Civilian Personnel under Program IV of the AFP as regard to its compliance with the requisites, content, formality and timeliness of filing under:

1. Republic Act (RA) 6713 (*Code of Conduct and Ethical Standards for Public Officials and Employees*);
2. CSC Memorandum Circular Nr 10, s. 2006, as amended by CSC Resolution Nr 1300455 promulgated on 04 March 2013 and CSC Memorandum Circular Nr 03, s. 2013; and
3. GHQ AFP SOP Nr 09 dated 28 June 2017 (*Guidelines on Statement of Assets, Liabilities and Net Worth*);

WHEREAS, the Committee, upon consolidation and review of all SALN for CY 2023, Certifications of Compliance, Resolutions and Summary Lists of Filers, finds, that:

1. Twelve Thousand Four Hundred Eighty-Three (12,483) of Twelve Thousand Four Hundred Eighty-Five (12,485) Military and Civilian Personnel under Program IV of the AFP have complied with the filing of SALN for CY 2023;
2. The submitted SALN for CY 2023 of the 12,483 Filers were substantially executed in conformity with the requisites, content and formality of SALN under said statute, CSC Memorandum Circular and GHQ AFP SOP;


